Schedule for Children, Juniors and U25 Drivers

Children, Juniors and U25 Drivers competition will be held as national competitions, but using the FEI rules as the CAI2* in all disciplines, except that dispensation is given concerning the carriages. This means, that Children, Juniors and U25 Drivers car participate with only a marathon carriage without adjustable axel/width in all disciplines., but it is preferable to use two carriages (dressage-and marathon carriages) according to the FEI rules. In case of too few competitors, will the Junior and U25 Drivers classes be combined to one.

Number of drivers

In all classes and categories, the number of drivers is open for as many participants that want to compete and/or the OC have the possibility to manage.

Following categories can participate in the event and in following dressage tests:

Children : Single pony Dressage test: Ch P1

Juniors : Single pony and Pony pair Dressage test: J (former 4A)
U25 Drivers : Single pony, Pony pair and Single horse Dressage test: 3*A HP1-2

Marathon-competition:

This competition will be in accordance with FEI Driving Rules

Children

<u>Controlled Warm-Up:</u> There will be a Controlled Warm-Up with a maximum time allowed of <u>30</u> <u>minutes</u> in a designated warm-up area with minimum 5000 square meters. The Controlled Warm-Up will be properly stewarded and with a judge in attendance.

There will be a marathon-type obstacle for preparation purposes situated in a separated area. Each Driver may use the obstacle for a <u>maximum of 2 minutes</u>, prior to the start of Section B.

<u>Cool Down:</u> After finishing Section B the Cool Down area will be entered. In the Cool Down area, the turnout must only walk. The Drivers do not need a groom as it is a closed area, however, they may walk besides the Carriage. The Cool Down must take <u>between 10 and 15 minutes</u> at distance of minimum of 800 meters and a maximum of 1200 meters

Juniors and U25 Drivers

<u>Controlled Warm-Up:</u> There will be a Controlled Warm-Up with a maximum time allowed of <u>30</u> minutes in a designated warm-up area with minimum 5000 square meters. The Controlled Warm-Up will be properly stewarded and with a judge in attendance.

There will be a marathon-type obstacle for preparation purposes situated in a separated area. Each Driver may use the obstacle for a <u>maximum of 2 minutes</u>, prior to the start of Section B.

The Drivers do not need a groom as it is a closed area, however, they may walk besides the Carriage. The Cool Down must take <u>between 10 and 15 minutes</u> at distance of minimum of 800 meters and a maximum of 1200 meters.
